 - a) Based on previous MCRW practices, any current member may nominate another member, only if she has notified the chairman, prior to the meeting on October 8, that the member being nominated has been consulted and concurs with the nomination and is willing to serve in that capacity for the designated term if elected.
 - b) The nominating member or the member who is a candidate must be prepared to make a short candidate resume' of her political activities regarding MCRW, TFRW, the Republican Party, on any level, and/or Republican candidates for previous elections. Also include a brief summary of skills and talents, which would showcase her ability to carry out the prescribed duties.

OFFICERS AND EXECUTIVE BOARD

Section 1: Officers:

The officers of this organization shall be: President, 1st Vice President, 2nd Vice President, Secretary, and Treasurer. All officers and/or committee chairmen shall be registered voters of McLennan County.

Section 2: Duties of Officers:

- (a) **The President** shall preside at all meetings of the organization and the Executive Board, shall appoint chairmen of all standing and special committees and the
 - Political Action Committee Treasurer, with the exception of the Nominating
 - . Committee. The President shall appoint a parliamentarian, shall serve ex officio as a member of all committees except the Nominating Committee, and shall have general supervision of the work of the organization. The President shall be a citizen of the United States.
- (b) **The First Vice President** shall perform the duties of the President whenever the President is absent or otherwise unable to serve. She shall be an ex officio member of all committees except the Nominating Committee. She shall perform such other duties as the President may designate.
- (c) The Second Vice President shall perform the duties of the President or First Vice President whenever the President or First Vice President is absent or otherwise unable to serve. She shall be an ex officio member of all committees except the Nominating Committee. She shall perform such other duties as the President may designate.
- (d) **The Secretary** shall keep a factual and unbiased record of the proceedings of all meetings of the organization and the Executive Board, shall prepare the correspondence of the organization, shall have custody of all records pertinent thereto and shall perform such additional duties as may be required of her office.
- (d) **The Treasurer** shall receive and be custodian of all funds of the organization and shall pay bills upon authorization by the President. The Treasurer shall keep an account of all moneys received and disbursed to the membership and shall give a report to the membership at each regular meeting of the organization. She shall submit her financial records to the internal review committee for an end of year financial review no later than December 31. She shall be Chairman of the Finance Committee.
